

And whereas if any vacancy made in Board of trustees these vacancy can be fulfilled by co-option. Whereas the settler is desirous of establishing a trust for public charitable objects.

And whereas the trustees have, at the request of the settler, agreed to act as the first trustees of these presents as testified their being parties to and executing these presents.

And whereas it is necessary to declare the aims and objects of the public charitable public trust, being constituted under these presents.

**NOW THIS INDENTURE WITNESSES AS FOLLOWS: -**

1. That, in order to effectuate his aforesaid desire, the settler has set apart and handed over to the trustees, a sum of Rs. 51,000 (Rupees Fifty One Thousand Only) (hereinafter called the "Trust Fund" which expression shall include cash and any other property of investments of any kind whatsoever into which the same of any part Thereof might be converted, invested or varied from time to time which may be acquired by the trustees or may come to their hands by

virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

That the name of the trust shall be "RAMNATH EDUCATIONAL AND WELFARE TRUST" and Registered office will be situated VILL – PAGARA BAZAR, P.O-SAHDIGRI, P.S.-BIJAIPUR, DIST-GOPALGANJ, PIN CODE-841508 it can be changed at such other place as the board of Trustees may decide from time to time.

**Administrative/ Branches or Project Offices :** Trust may have administrative/ or branches or project offices in such place or places as decided by the Board of Trustees time to time within the operational area of the Trust under the overall guidance and control of the registered office.


**Area of Operation:** The operational area of the trust shall be whole India and may be reduced as Trustees may decide.

**Fund of the Trust:** The assets, together with all further donations, contributions, grant and loan in any shape or form made to the said Trust from time to time, and rents, profits and income there of and the stocks, funds and properties representing the some shall be held by the Trustees upon Trust for the objects and purposes and subject to powers and provisions hereinafter set out.

2. That the objects for which this trust is established are :-

- 2.2 To organize, promote, undertake, sponsor, carryout, all programmes for the benefit of naturally challenged person, schedule caste, schedule tribes, people under poverty line, old-age, widow, and down trodden irrespective of caste, creed, sex and religions.




- 2.3 To establish develop, maintain schools, colleges, libraries, universities, laboratories, skill developments centers, competition, preparation centers, yoga and spiritual centers, sports training centers, vocational training centers, research and other Institutions for the development and advancement of education and diffusion of knowledge among the public in general.
- 2.4 To establish, maintain and run studentship, scholarship and award programme and render other kind of aid to student including supply of study materials, books, stipend, medals and other incentives.
- 2.5 To Organize programme for the promotions of pre-primary education, non-formal education, computer & information technologies, leadership, development, techno-entrepreneurship development educational, infrastructure research and development, socio-scientific research, management.

- 2.10 To establish run Drug De-addiction center and undertake rehabilitation programme for drug-abuse. Also organize awareness —programme for the control of drug-menace and abuse.
- 2.11 To conduct and undertake the research of technologies advancement, productivity enhancement, cost effectiveness technologies and methodologies in the field of agriculture, allied industries, cottage industries, veterinary and co-operatives.
- 2.12 To conduct plantation, including medicinal plant, edible oils & non-edible oils cultivation, Bio-diesel plant with the activity of oil Extraction from seeds and plant, refining the extracted oil and marketing of the oil & oil products.
- 2.13 To conduct awareness and exposition programme of appropriate and low cast technologies agriculture.




- 2.14 Conduct the programmes to ensure nutrition security, safe food processing and standardization.

To develop the infrastructure for the easy and safe delivery of agro-products. Also establish and run financial institution for the benefit of agriculture and allied industries-related people.

- 2.19 To undertake awakening and intervention programmes for enforcement of environmental law, Access to environmental information, town and country planning, integrated pollution control, atmospheric pollution, waste management, water pollution, waste management, water pollution, sound pollution, exerted disposal sedimentation and coagulation, treatment and disposal of sewage and silage, bio-gas water treatment methods and other nature conservation programmes.






with property of the Trust in any manner whatsoever and get loan for the fulfillment of objective of the trust.

- 2.42 To undertake, develop, manage, arrange or organize antique show, art show, audio and video show, fashion show, magic show, thematic popper show, charity premier show, lottery, car rally, dance events, fancy dress competition, fete greeting card and handicraft exhibition film shows foundation or endowment of award and prizes.
- 2.43 To undertake, carryout, promote, sponsor, discharge, full fill, participate, collaborate, manage or organize the programmes with people's co-operation, national and international Government and Non Government agencies and to carryout all necessary acts for the achievement of the objectives.
- 2.44 All the incomes, earnings, movable/immovable properties of the Trust shall be solely utilized and applied towards the promotion of its Aims and objects only as set forth in the ( deed of the Trust and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or the past member of the Trust or to any person claiming through any one or more of the present or the past members. No members of the Trust shall have any personal claim on any movable or immovable properties of the Trust or make any profits, whatsoever, by virtue of trustee.
- 2.45 To accept loan, Grant-in-aid, donation (Either in cash or kind), Subsidy or other assistance lawfully, either from National and/ or International agencies for the attainment of the objective of the trust.
- 2.46 To undertake, organize, investigate, participate, sponsor, the human right programmes including awakening of human rights, preservation of fundamental rights, protection & safeguards to the victims of human rights violations, for the freedom, dignity and peace of the people. Also, undertake study, research, publications, treaties with national and international institutions and award programmes, for the effective implementation of Human Rights.
3. All the activities shall be Non Profitable and shall be done on 'No Profit-No Loss' basis.
4. All the Incomes, earnings, movable/immovable properties of the trust shall be solely utilized and applied towards the promotion of its aims and Objects only as set forth in the deed of its Aims and objects only as set forth in the deed of the trust and no profit Thereof shall be paid or transferred directly or indirect/ by way of dividends, bonus, profits or in any manner whatsoever to the present or the past members. No members of the trust shall have any personal claim on any movable or immovable properties of the trust or make any profits, whatsoever, by virtue of his

5. That the Trust Fund may be augmented by the income from the Initial fund and also by donations and other contribution from time to time.
6. That the Trust fund shall not be applied for any purpose other than those specified in Para 3 herein above unless the other objects added to the trust objectives.
7. That the Trustees shall always maintain proper accounts of The Trust, which shall be kept at the office of the Trust.
8. Subject to the Provisions of Income Tax Act. 1961 as amended from Time, The Trustees will keep the Trust Fund or such portion thereof, as they may, in Their absolute discretion, think fit and proper, without being answerable or accountable to the beneficiaries or any other party for any loss invested in such shares, stock, securities and debentures of acquisition or mortgage by way of fresh charge on any immovable property in India, of free-hold or lease-hold tenure, and may deposit the amounts with any scheduled Bank, company or private firm or Individual on such terms and conditions as they think fit. In the matter of investment of Trust funds, the provisions of section 20 of the Indian Trust Act shall apply; in the event of Trustees purchasing any immovable property or properties or advancing moneys or mortgage, they shall be entitled to accept such title or evidence of title as they shall think fit in Their absolute and uncontrolled discretion. The Trustees shall have power, if any deed it in their absolute discretion to sell the Trust Fund or any part thereof and any such immovable property purchased by them under the power aforesaid and any other shares, securities, etc.. and stand possessed of the money to arise from such sale upon after paying there out the expenses pertaining to such sale upon the Trusts and with The subject to powers and under these presents declared and contained concerning the Trust Fund which or the proceeds thereof, shall have laid out in purchase of property or properties as aforesaid or such of them as shall be then subsisting and capable of taking effect.



#### 9. ADVISORY BOARD :

The Board of; Trustee is authorized to appoint or nominate any time, the Advisory Board for guidance or to solve any matter/ issue. Board of "Trustee of the Trust can nominate any trustee/ Office- Bearer as the Settler-Cum-Chairman of this kind of advisory Board. Member of Advisory Board have no power to vote in any Board of Trustee meetings of the Trust. Advisory Board Members are also not eligible for nomination as Trustee. The recommendations made by Advisory Board in any matter are only suggestive nature and binding on Board of Trustee to accept it.

#### 10. POWERS AND FUNCTIONS OF THE BOARD OF TRUSTEES :

For the furtherance of the objects of the trust, the trustees shall have the following powers:



- 10.1 To accept any donation, contribution grant loan or subscription in cash or kind, from any person(s) body of persons or Trust, Govt./ semi-Govt. department or agency, financial institution, bank, national or international 1 donor with or without conditions.
- 10.2 To apply the whole or any part of the income of the trust, or the trust fund or accumulations the; etc, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time of time.
- 10.3 To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.
- 10.4 To open account in the name of the Trust, with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
- 10.5 To adjust, settle, compromise, compound refers to arbitration, all actions. Suits claims, demands and proceedings regarding the Trust Fund.
- 10.6 To Engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator of Settler-cum-Chairman or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.
- 10.7 To make very alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs Thereof and/or running any institution in furtherance wance of the objects of the Trust Fund or part thereof for any of the objects of the Trust.
- 10.8 To start, abolish, discontinue and restart any charity of charitable institutions for the benefit of general public and to impose any condition to any subscription or donation made by them.
- 10.9 To set apart and or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for the corpus of the Trust- Fund or part thereof for any of the objects of The Trust.
- 10.10 To join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to end in conformity with he objects and nature of this Trust.
- 10.11 To give aid by way of donations out of the income or the corpus of the Trust fund or otherwise, to different charitable institutions, may have been established or which hereinafter be established for the like charitable purpose mentioned in these

- 10.12** To invest surplus funds, if any, of the Trust in securities approved by the law relating to Trusts as per IT Act 1961, or In such manner as The Board of Trustees may think fit and proper in the best interest of the Trust.
- 10.13** To settle all accounts and to compromise, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- 10.14** To borrow money either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the trustee to make such borrowing on payment Payment of such interest and otherwise on such term and conditions as they may in their absolute discretion think fit.
- 10.15** To apply to the Government, public bodies, urban, local municipal, district and other bodies, corporation, companies, or persons for and; to accept grant of money and of aid, donations, gifts, subscriptions, affiliation and other assistance including lease and substance of property with a view to promote the objects of Trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to put to any proper condition, upon which such grants and other payments including taking land on lease may be made.
- 10.16** To take over or amalgamate with any other Charitable Public Trust, association, or institution with similar objects.
- 10.17** To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar or ;ne objects of this Trust and on such terms and conditions as may be thought expedient.
- 10.18** To take land property on lease and then after sublease the land/property to the farmers and other organizations like co- operative society.. urban public bodies/gram panchayat or,. any being thereof in rural area/local municipal/ district and other bodies corporation/company for farming/agriculture/ plantation purposes.
- 10.19** To purchase or otherwise acquire and undertake all or any part of the pr-operty, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized 10 amalgamate.
- 11.** The Trustees shall be accountable only for such money, and funds, which will actually come into their hands.

13. The Settler-cum-Chairman for the time being will be at liberty To appoint additional Trustee within the number mentioned above for such period of on such terms as to retirement and reappointment as the trustees for the time being consider proper
14. **A. PERSON SHALL CEASE TO BE A TRUSTEE EITHER:**
- 14.1 If he/she without leave of absence does not attend three consecutive meeting of the Trustees or for one calendar year, whichever is longer, or for one calendar year, whichever is longer, or
- 14.2 If he/she is requested to resign by 2/3rd or as near thereto as possible of the remaining trustees.
- 14.3 In the absence of Settler-Cum-Chairman, Secretary & Treasurer . will take charge and function of Settler-Cum-Chairman.
15. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so. The Trustees may from Time to time frame rules for the conduct and regular the Tiettings of trustees. In the absence of such regulations:
- 15.1 Two Trustees shall form a quorum for a meeting of the Trustees.
- 15.2 All matters will be decided mutually by the Trustee.
- 15.3 Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of Trustees.
- 15.4 Settler-Cum-Chairman, Secretary & Treasurer have management of The affairs of the trust and the over all supervision and superintendence of the trust and all institutions/units run by the trust and all matters incidental thereto.
16. The Trustees shall have The power to determine in case of doubt whether any money of property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.

17. **MAINTENANCE OF BOOKS OF ACCOUNTS :-**

Regular books of accounts of the Trust shall be maintained incorporating all the revenue and expenditure and such books shall be closed once every 31st March.

18. The Trust and the Trust funds shall be irrevocable for all the times.

19. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose, which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.

20. The accounts of the Trust shall be audited every year by a Chartered Accountant or a firm of Chartered Accountants, that will be appointed by the Board of Trustees with the consultation of the Settler-Cum-Chairman.

21. The audited accounts of the Trust shall be adopted at a meeting of the Board of Trustees called for the purpose, and remuneration of Chartered Accountant or Firm of Chartered Accountants shall be fixed by the Board of Trustees.

22. **POWER & FUNCTION OF THE OFFICE BEARER SETTLER-CUM-CHAIRMAN :**

22.1.1 The Settler-Cum-Chairman shall preside at all meetings of the trust, when he/she is present and shall exercise such other powers as are conferred upon her by these rules. The Settler-Cum-Chairman may call for an emergency meeting through Settler-Cum-Chairman Signed notice in a shorter period. The decision of Settler-Cum-Chairman that a resolution has been carried or lost shall be conclusive, unless such a decision is challenged and a poll is demanded; on poll being demanded, the same shall be taken in such manner, as the Settler-Cum-Chairman shall have a second or casting vote.

22.1.2 The Settler-Cum-Chairman shall be the principal executive officer of the Trust and shall be the principal executive officer of the trust and shall preside over the meeting of the trust.

22.1.12 He/she shall be able to seize all powers to the and establishment of the Trust, and vest in him/her suspending the unit's management in unavoidable emergent and desirable circumstance, in the interest of the concerned establishment, institution to maintain to every purpose of the Trust and shall form an ad-hoc committee to run to business of the establishment/institution till the position improves. It shall be incumbent on the part of the Settler-Cum-Chairman to have the Settler in good confidence and obtain approval in the Board of Trustee.

22.1.13 The Settler-Cum-Chairman shall see that the every collected amount is deposited in Bank in time as per rule.

22.1.14 Settler-Cum-Chairman will submit in the meeting the report of he working of the Trust and all its units along with detailed statements of receipts, expenditure of existing resources of fund of money bank balance of the Trust and institution if required.

22.1.15 He/she can authorized work, rights, functions and duties to any of the Trustees in writing and in Trust to perform independent ally with the liabilities and also seize anytime all or part of the work entrusted to the Trustees in absence of the managing on leave or absent for long period or for some time.

## 22.2 SECRETARY:

22.1.2 He/she shall produce the accounts of the Trustee before Settler-Cum-Chairman for approval.

22.3.4 In the absence of Secretary, Treasure will take charge and function of Secretary.

**23. ALLOWANCE TO TRUSTEES & OFFICE BEARERS**

If at any time any Trustee acts as a whole time bearer of the Trust or tenders any special service, the Board of Trustees may in its discretion pay such remuneration or allowances to such Trustees as it may think.

**24. BANK OPERATION:**

24.1 The bank accounts will be opened by the name of the Trust for its registered/administrative/branches, Project offices, centres or institutions run or conducted by the Trust with a nationalized or scheduled bank or other bank appoint or permitted by Reserve Bank of India or in Post Office and shall be operated by joint signature.

24.2 The joint signatures of any two of the Settler-Cum-Chairman, Secretary and Treasure will operate the bank accounts.

**AMENDMENT:**

This Trust, Trust-fund, trust objective and the provision relating to the appointment of the Settler constitution the Board are irrevocable. Subject as aforesaid, the terms of this deed may be amended, altered or modified by a majority of 2/3rd members of the Board present and voting in a meeting called for the purpose.

Provided, however, that no amendment contrary to the objects of the Trust herein before set forth shall be valid and effective.




